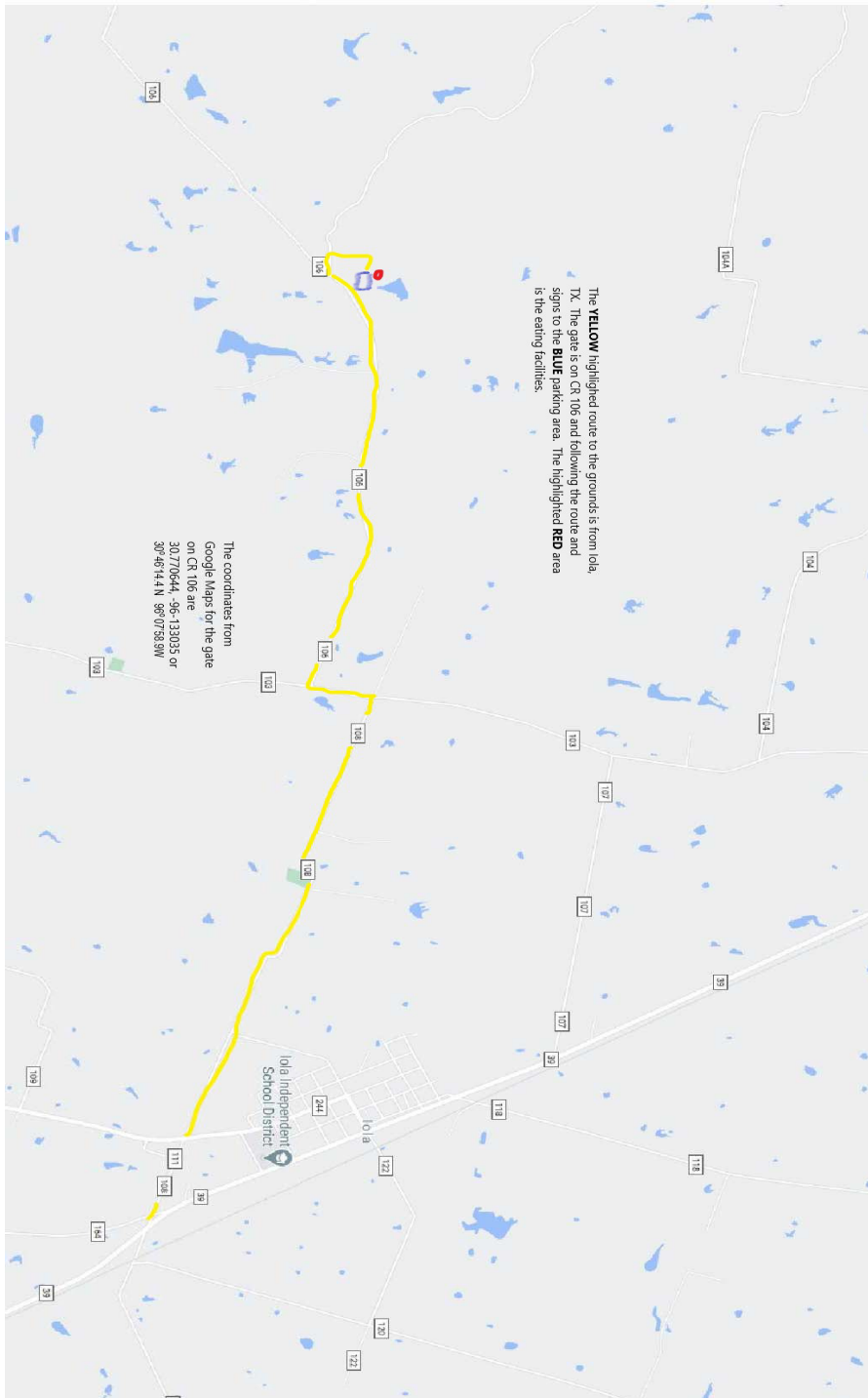

COURSES AND BIRDS

All Stakes will be run on multiple or continuous courses without bird field and the Field Trial is being run under the Flexible Format Option, and the club reserves the right to rearrange the running order of the stakes, and add or rearrange judges if conditions warrant.

Bobwhite Quail will be released in all stakes except Open Puppy.

A blank cartridge will not be fired in the puppy stake.

Call back to retrieve in the Open Gun Dog & Amateur Gun Dog stakes.

No horses will be provided by the Club.

Collaring will be allowed in all stakes.

Stakes with less than four entries will be cancelled.

No Bitches in season will be allowed to run, except in the Grand Limited Stakes.

Grand Limited Stakes are open to German Shorthaired Pointer Only.

Use of AKC approved tracking collars will be permitted. The locator for any collar used will be controlled by the Field Trial Marshall and will be activated only after a dog has been eliminated from contention.

Any dog located by use of a tracking collar cannot place.

Collars will not be provided by the GCGSPC.

From College Station, Hwy 6 to SH 30 E to CR 174 (left) to FM 244 (left) to FM 108 (left) to RM 103 (left) to FM 106 (right). There are several ways to get to the ranch—note that some roads from College Station are all white gravel and narrow. Camping is allowed on the grounds (IN A DESIGNATED AREA—please pay attention to signs). No electricity for rigs. Water on the grounds. There is water on the course.
